1. Introduction

The SPAMI Day, a **regional celebration of Mediterranean marine conservation and protected areas**, was set up by the Contracting Parties to the Barcelona Convention at their COP 22 (Antalya, Türkiye, 7-10 December 2021), and is officially celebrated on 15 April of each year.

The objective of the SPAMI Day is to promote the List of **Specially Protected Areas of Mediterranean Importance** (SPAMIs), in other words, exceptional marine areas, managed in an exemplary manner, and more broadly, to raise awareness about ocean conservation.

The theme of SPAMI Day 2023 focused on the co-management and involvement of Civil Society Organizations (CSOs) in the management of Marine and Coastal Protected Areas (MCPAs). By selecting this theme, the aim was to value and encourage all the dynamics involving different stakeholders within SPAMIs, which contribute to transformative change towards preserving and restoring ecosystems and living in harmony with nature.

As part of the third edition of the SPAMI Twinning Programme, funded by the Italian Ministry of Environment and Energy Security, SPA/RAC provided support to Mediterranean Civil Society Organizations (CSOs) in implementing activities to celebrate the SPAMI Day and promote the conservation of marine biodiversity across six SPAMIs, in collaboration with their respective managers.

In this context, the mini project Celebrating and promoting SPAMIs in Karaburun-Sazan MPA by raising awareness on marine and coastal biodiversity was proposed and implemented by Flag Pine NGO in collaboration with Regional Administration of Protected Areas Vlore.

The general purpose of this project, is to raise awareness and promote the protection and conservation of biodiversity in Karaburun-Sazan MPA by by promoting sustainable behaviours and highlighting its status in the SPAMI list.



2. Presentation of the Association Flag Pine

"Flag Pine" is a local NGO, established on 08.03.2013, decision nr.3526, with the main office in Orikum. This NGO has a good experience on promoting the sustainable development in protected areas in collaboration with local community and local government. Flag Pine is organized as a Non-Governmental Organization, according to the predictions of the Albanian Law.

The main mission of Flag Pine is to promote the protection of terrestrial and marine ecosystems and provide solutions to mitigate environmental problems by creating bridges of collaboration with local community and government institutions. To achieve this mission the association has implemented several projects and is part of networks for nature protection. It is part of of the Network of NGOs "Rrjeti per Mbrojtjen e Natyrës" (Network for nature protection), who has representatives in 6 regions of Albania and ENGONA the network of Albanian civil society organizations. Since 2018, Flag Pine is co-managing the Karaburun-Sazan National Marine Park in collaboration with Regional Administration of Protected Areas, Vlore.

Main objectives of Flag Pine are:

- Strengthening protection and sustainable development of Protected Areas in Vlora Bay.
- Increasing the collaboration between local community and local government regarding the involvement of locals in decision making about environment and protected areas.
- Raising awareness about the values of natural and cultural treasures of protected areas.
- Educating youths and communities about the importance of environment and sustainable development through environmental education.



3. Dedicated Team for the Mini Project

The implementation of the activities will be done by Flag Pine, where two staff of the NGO will be directly engaged to ensure the successful implementation of the activities. The implementation of the awareness raising activities in the Visitor Center of Karaburun-Sazan MPA and Sea turtle Rehabilitation Center will be also facilitated by RAPA Vlore staff who is responsible for managing these facilities.



4. The Mini Project

Karaburun-Sazan National Marine Park, proclaimed in 28 April 2010, is the first marine protected area of Albania and consists of 12,437.7 ha (updated in 2022) located around Karaburun Peninsula and Sazan Island. The protected area is managed by National Agency of Protected Areas represented in local level by Regional Administration of Protected Areas Vlore (RAPA Vlore). Since 2018, a new management approach is implemented in Karaburun-Sazan MPA, where it is comanaged by RAPA Vlore and a local NGO, respectively Flag Pine NGO. The MPA hosts several important habitats such as *Posidonia oceanica* meadows, infralittoral algae forests, coralligenous biocenosis and important species such as the monk seal, sea turtles, dolphins, red coral etc. Due to its importance and due to these biodiversity values the MPA became part of SPAMI list in 2016. The general purpose of this project, is to raise awareness and promote the protection and conservation of biodiversity in Karaburun-Sazan MPA by by promoting sustainable behaviors and highlighting its status in the SPAMI list. Through dedicated activities and concrete interventions such as awareness raising activities and creation of dedicated spaces for environmental education youths, are empowered with knowledge regarding nature and the importance of sustainable and ecofriendly behaviors, as well as park visitors and local community.



5. Activity Results

5.1. Production of Awareness Raising Materials

Within the frame of the project, aiming to raise awareness regarding the values of Karaburun-Sazan MPA and the importance of SPAMI areas was produced a brochure. 500 copies of the brochure (English and Albanian) were produced and were placed in Radhima Visitor Center where are being used by Albanian and foreign visitors. This material provides a good and adequate source of information regarding the biodiversity of Karaburun-Sazan MPA and regarding the establishment of SPAMIS and SPAMI list.

Result: Park visitors and local community are more aware regarding the importance of establishment of SPAMI and the importance of the conservation of Karaburun-Sazan MPA.




5.2. Designing of murals and creation of micro-environment

Following the need for methods to bring children closure to nature and built an ecofriendly and sustainable relation with nature, were created two dedicated spaces for awareness raising in the premises of a local school ("Balil Pelari" School). One space, dedicated entirely to the marine environment, includes 2 murals which give information about marine species and the problems of the environment and also 2 other murals which aim to make children aware on their role in the protection of the nature.

For the designing of the murals was engaged a painter and also pupils from the pilot school for which were given also certificates. The designs and the preparation of the murals followed the discussions and confirmations with the director and the biology teacher of the pilot school.

In addition, another dedicated space for the creation of a micro-environment was established to "Balil Pelari" School, which aims to engage the pupils in continuity in nature related activities. Through this micro-environment the pupils learn nature processes, how the nature evolves and the relationship between nature elements such as soil, water and living organisms. This space is used and will be used in continuity by the school and pupils to engage them in nature-based activities such as planting, exploring etc..

5.3 Environmental education at Visitor Center of Karaburun- Sazan MPA and Sea Turtle Rehabilitation Center

On the occasion of SPAMI Day 2023 on 15 April were organized two awareness raising activities in the premises of the Visitor Center dedicated to Karaburun-Sazan MPA in Radhima and the premises of the Sea Turtle Rehabilitation Center in Vlore. The implementation of these activities was done in collaboration with RAPA Vlore staff which manages this facilities. Aiming to broaden the range of the target group in these two activities were engaged 52 pupils from two schools, the primary school "Hasan Mëhilli" of Dukat and the high school "Hasan Pulo" of Orikum. During the activities, through a PowerPoint presentation and on site materials the pupils learned regarding the biodiversity of Karaburun-Sazan MPA and the importance of preserving it. In addition, they learned regarding the MPA status in the SPAMI List and the importance of this list. At the end of the activities certificates of participation were given to all the 52 pupils. Please find in Annex the programe of the activities.

The celebrations of the SPAMI Day were done using the hashtag #NeJemiSPAMI/ #WeAreSPAMI and a dedicated banner with this hashtag was produced and used during the awareness raising activities. Also, was produced and shared in social media a video highlighting these activities. In the celebrations of the SPAMI Day we engaged also the National Agency of Protected Areas in Albania which covered the activities in their social media under the hashtag #NeJemiSPAMI/ #WeAreSPAMI/ #WeAreSPAMI.



Result: More than 50 pupils engaged in two awareness raising activities and learned about the biodiversity of Karaburun- Sazan MPA and SPAMI areas.
